1. SCOPE OF WORK:

Installation work along with installation material and supply of material "in Provision of Telecommunication arrangements at stations in Velachery - St. Thomas Mount section of Chennai division in connection with MRTS - Phase-II Extension work."

(Detailed work schedule is attached as Annexure-III).

2. ELIGIBILITY CRITERIA:

- a. The Tenderer must have valid GST and PAN No.
- b. The Tenderer must have executed and completed any telecom / signaling work (attach details with supporting documents) of Railways and should have made turnover Rs. 1 Crs. (cumulative) during the last 3 years i.e 2023-24 or 2022-23, 2021-22 & 2020-21. Contractors having experience with Railways will be preferred. Proof of experience has to be enclosed along with bid.
- c. The Tenderer should sufficient technical and non technical manpower (Engineers, Diploma as well as Labour) for execution of work as per Railway requirement who are Proficient in installation, laying, trenching, jointing testing and termination of optical fibre and quad cables.
- d. The Tenderer should have the ability to meet the running expenditure, to execute the contract.
- e. Tenderer should not have been blacklisted by any Govt. / PSUs or any other agencies earlier. An undertaking to be enclosed with the offer.

3. EMD

- a. The bidder(s) are required to deposit a sum of Rs. 25000/- (Rupees Twenty Five Thousand Only) as Earnest Money. The earnest Money can be deposited in the form of Demand Draft in favour of 'Punjab Communications Limited' payable at Chandigarh. Bid unaccompanied by the requisite earnest money will be summarily rejected.
- b. The earnest money will be returned to the unsuccessful bidder(s) after finalizing the tender and till then PUNCOM will not be liable to pay any kind of interest on the earnest money. The successful bidder's EMD may be adjusted with the security deposit.
- c. The Bid Security (EMD) may be forfeited, If a bidder withdraws his bid during the period of validity specified in the bid form and In case of successful bidder, If bidder fails to sign the contract.

4. Security Deposit

The Security Deposit equivalent to 6% of the total contract value as per following details will be deposited/ deducted by successful bidder.

- a. Initially 1% of the contract value to be submitted in the form of Bank Guarantee at the time of award of contract or the EMD of the successful bidder which was submitted at the time of bid will be converted into Security Deposit.
- b. The balance 5% will be deducted / retained from the running bills submitted by successful bidder till it reaches total 6% of the contract value and this amount will be released after completing the project is all respects.
- c. The security amount will be forfeited in case the successful bidder fails to execute the contract as per the requirements of Railways.

5. Payment Terms :-

The payment of installation work and supplied material will be paid as per following details:-

a. Erection and services only: -

- i. 85% payment on completion and duly certified by the concerned SSE of Railways or official of Puncom.
- ii. 10% payment after MB entry by Railways.
- iii. 5% payment after completion of whole work.

b. Supply & Installation (combined):-

- i. 70% payment on supply and on acceptance by consignee.
- ii. 10% payment after installation and duly certified by the concerned SSE of Railways or official of Puncom.
- iii. 10% payment after MB entry by Railways
- iv. 10% payment after completion of whole work.

c. Supply Only:

- i. 85% payment on supply and on acceptance by consignee
- ii. ,5% payment after MB Entry by Railways
- iii. 10% payment on completion of whole work.

a. OTHER TERMS & CONDITIONS:

- a. All terms and conditions as per Railways tender No. Tender No: SG-CNMTP-23-1-VLCY-STM-TE Dated: 27/01/2023 (General, Special etc) and LOA no. Letter No:XSTE-CN-MTP-MSC-S AND T / SG-CNMTP-23-1-VLCY-STM-TE / 00814660075621 Dated:21/04/2023 shall be applicable on contractor on back-to-back basis.
- b. The quoted prices should be firm and no escalation in prices is permitted on any grounds throughout the contract period.

- o. The PUNCOM may at its discretion, extend this due date and time for the submission of bids by amending the bid documents and in such a case, all rights and obligations of the PUNCOM and bidders subjected to previous due date and time, will be subjected to the extended due date and time.
- p. Any bid received by the PUNCOM after the due date and time, shall be rejected and returned unopened to the bidder.

7. EVALUATION:

a. PUNCOM shall examine the Bid to determine whether these are complete and are generally in order, without computation errors, with required enclosures and appropriate documents.

b. PUNCOM may waive any minor infirmity of non-conformity or irregularity in a bid, which does not continue a material deviation, provided that such waiver does not prejudice or affect the relative ranking of any bidder.

8. Award of Contract

- a. The successful bidder, whose offer is found acceptable as per terms and conditions of the tender document, will be intimated so by the PUNCOM in writing.
- b. The successful bidder shall give their acceptance in writing within 15 days of issue of intimation.

9. SETTLEMENT OF DISPUTES

- a.
