Textual Information(1)

The Company came up with a Buy-back Offer in the year 2003. As the Offer was oversubscribed, accordingly proportionate shares were accepted & balance shares were returned to the Shareholders who had tendered their shares in the buy-back offer. At that time during the process of returning, 419 shares were bounced back from Demat accounts of 10 shareholders due to technical reasons such as rejected by other DP, closed failed during settlement etc.. Accordingly these 419 shares are lying in the escrow account with M/s Karvy Computershare Pvt. Ltd., Hyderabad. The voting rights on these shares shall remain frozen till the rightful owner of such shares claims the shares.
